

**STUDY ABROAD PROGRAM AGREEMENT
BETWEEN
NJC “AL-FARABI KAZAKH NATIONAL UNIVERSITY” (KazNU)
AND
KOOKMIN UNIVERSITY (KMU)**

NJC “Al-Farabi Kazakh National University” (hereinafter referred to as “KazNU”) and Kookmin University (herein after referred to as “KMU”) join in the following agreement to promote academic cooperation through study abroad program between two institutions.

1. Description

The study abroad program will allow home university students to attend host university as fee-paying students. These students shall be referred to as “Visiting Students” and may register up to two (2) semesters at the host university.

- (1) Home university: the university providing visiting students
- (2) Host university: the university accepting visiting students

2. Selections of Visiting Students

Visiting students will be recruited, selected and nominated by home university to host university. Home university will forward the application to host university for final approval.

3. Approval of Visiting Students

Host university will accept full-time students from home university who meet the following requirements:

- (1) At KazNU:
- (2) At KMU: Overall G.P.A. of 3.0/4.5 and Korean proficiency equivalent to TOPIK level 3 or English proficiency equivalent to TOEIC 800

4. Courses and Credit Transfer

Visiting students will take courses from host university and transfer the credits to home university after completion of the study abroad program. At XXX (information on courses for study abroad students). At KMU visiting students take 12~15 credits/semester from General Education and their assigned major/department.

5. Responsibility of Visiting Students

Visiting students will satisfy the host university that they have adequate funds for their study abroad in the host country and pay all travel, medical insurance, room & board during the study abroad. Visiting students will maintain mandatory insurances according to host university’s policy.

6. Tuition & Scholarship for Visiting Students

Visiting students are responsible for their tuition during their study abroad at host university. While it is not mandatory, host university will allocate full or partial

scholarship for visiting students to facilitate the study abroad between both institutions. At KazNU (information on tuition study abroad students). At KMU visiting students will pay the international student tuition for the assigned major/department and entrance/admission fee will be waived.

7. Period of Agreement

This agreement shall be effective for an initial period of five years (from the date of the last signature) unless terminated by either party in the form of a written notice submitted at least 90 days in advance of the proposed termination. Thereafter, the agreement will be renewed automatically every year unless one party gives the other a written notice of termination at least 90 days in advance of the proposed termination. A notice of termination notwithstanding, students already admitted or enrolled at the host institution under this agreement may complete their studies through the end of that academic term.

IN WITNESS WHEREOF, KazNU and KMU have executed this Agreement as the date of last signature.
