		sufficient for a literature review	literature review. It is clear that there is a lack of fundamental research in the rather applied pension sphere and global crises area. It would be a great advantage to review the latest research especially on the pandemic in order to enrich the thesis.

The applicant submitted an Implementation act confirming the implementation of the research results at Joint Stock Company Unified Accumulative Pension Fund (Appendix A of the thesis)

The dissertation is presented on 129 pages of computer text (A4) and includes: normative references, notations and abbreviations, an introduction, three main sections, a conclusion, a list of references and appendix A. Materials are illustrated with 16 tables and 9 figures. Table 9 on page 81-82 is not clear and inconsistent with the main body text. Some words in Figure 6 on page 87 are written in Russian. Two tables 11 are presented on page 88 and 89. In Figure 9 on page 103 the forecasting is supposed to be until 2026 however period presented is covering 1990-2018. The idea of a forecasting based on dependence data is rational, but there is no continuation of the trend on the chart until 2026.

The content of the dissertation corresponds to the objective and tasks of the research, as a complete independent study contains a set of reliable scientific and practical results put forward by the applicant.

The dissertation work's problem statement, methods of its solution, scientific novelty and results obtained meet the requirements for the dissertations of applicants for the degree of Doctor of Philosophy (PhD) by Control Committee in Education and Science of the Republic of Kazakhstan.

Yessentay Aigerim's dissertation research on "The world financial crisis and national pension systems: impact assessment and development prospects" is recommended for public defense, the applicant deserves to be awarded the degree of Doctor of Philosophy (PhD) in the specialty "6D050013 – World Economy".
