## Thesis Relevance

Corporate Social Responsibility (CSR) has been gaining its importance everywhere around the world and this issue is especially significant for developing countries. Understanding factors that drive Corporate Social Responsibility is specifically important as it might help to facilitate companies' CSR activities. Therefore, researching the profitability factors that affect the Corporate Social Responsibility of a high interest and importance for many countries, including developing countries.

## Thesis Novelty

The current literature on Corporate Social Responsibility investigates how profitability of the company is impacted by its CSR activities. The novelty of this dissertation is that it changes the direction of causality and rather researches the effect of profitability on CSR activities of the company. Previous research mostly focuses on advanced markets and there is a lack of research on developing economies. Thus, another novelty of this research is is that it focuses on identifying what factors play an important role for the CSR activities in developing countries.

## Thesis Structure and Coherence

In terms of the contribution to the field and scientific language the work is very well written. The dissertation is structured in accordance with scientific publication so it is easy to navigate it. The
