UNIVERSITY NAMED AFTER AL-PHARABY  
1. STUDENT STATUS**

1.1 A student of KazNU is a person, successfully studying on educational higher professional education (baccalaureate) and / or after-higher professional education (Magistracy, PhD doctoral studies).

1.2 The student of KazNU is:

- patriot, perceiving successes country and university as their own; an example of conscientious and creative attitudes toward learning, aspirations for modern technologies;
- highly educated personality, self-perfection, knowledgeable national and world culture; respecting traditions other peoples;
- a law-abiding citizen, with a high level of moral and legal consciousness;
- an active participant in educational, scientific, research, public, cultural, sports life of the university.

**2. RESPONSIBILITIES OF STUDENTS  
High title of student of KazNU**

**Obliges:**

2.1 Strictly meet the requirements the Charter of the KazNU, the Code of Honor of Students KazNU, Internal Regulations, rules of residence in the hostel and other normative acts of the university.

2.2 To fully comply with the requirements of the education program the students, mastering them at a high professional level.

2.3 Actively participate in the scientific- research and socio-cultural activity.

2.4 Strengthen and develop the corporate culture of the university community, transfer of university traditions to students of junior courses.

2.5 Observe the requirements for your appearance during the training sessions.

2.6 Observe the subordination in relation to teaching and leadership university.

2.7 Be careful with equipment, technical means of training and other property, support in the premises and on the territory of the university is clean and tidy.

2.8 If you have information about possible threats to stability and order in the university is obligatory to inform the administration about this.

2.9 In all areas of activity, to know the high rank of a student Al-Farabi Kazakh National University .

**3. RIGHTS OF STUDENTS  
Students of KazNU have the right:**

3.1 To receive higher and postgraduate professional education in accordance with educational standards and acquire knowledge adequate to the current level of development of science, technology and culture.

3.2 Participate in the formation of an individual trajectory of learning.

3.3 In accordance with the established procedure, use the educational and material base, social infrastructure facilities and the University's information fund.

3.4 To receive additional (including paid) educational services.

3.5 Participate in the discussion and decision of the most important issues of the University, including through public organizations and university management bodies.

- 3.6 To take part in all types of research work, conferences, symposiums, present their work for publication, including in university publications.
- 3.7 Participate in the organization and conduct of cultural, sports, health and other events.
- 3.8 Create public youth organizations, associations not prohibited by the legislation of the Republic of Kazakhstan, to participate in their work.
- 3.9 Receive places in the hostel, if there is adequate housing of the fund.

#### **4. PROMOTION MEASURES AND DISCIPLINARY IMPACT**

- 4.1 For the success in the development of educational programs and active participation in cultural-mass, scientific, experimental and design work for students, various forms of moral and material encouragement are established.
- 4.2 For academic violations and non-compliance with internal regulations Row, stipulated by the Charter of the KazNU, the Code of Honor of the student KazNU, students can be subjected to disciplinary measures (remark, reprimand, severe reprimand) until expulsion from the university.
