#### **GUIDE FOR AUTHORS**

The article is submitted in electronic format (\*.doc, \*.docx, \*.rtf).

Font – 12, Times New Roman (*abstract, keywords, reference* - 10, *text of tables* - 9-11), alignment - the width of the text, spacing - single, paragraph indent - 0.8 cm, margins: upper and lower - 2 cm, left and right - 2 cm.

Figures, tables, graphs, diagrams, etc. are presented directly in the text with the indication of numbering and title (for example, Fig. 1 - Name of the figure). The number of figures, tables, graphs and diagrams should not exceed 20% of the entire article (in some cases up to 30%).

#### • Title

Titles has to be informative. Avoid abbreviations and formulae where possible.

#### Author names and affiliations

Please clearly indicate the given name(s) and family name(s) of each author and check that all names are accurately spelled. You can add your name between parentheses in your own script behind the English transliteration. Present the authors' affiliation addresses below the names. Provide the full postal address of each affiliation, including the country name and, if available, the e-mail address of each author.

## • Corresponding author

Clearly indicate who will handle correspondence at all stages of refereeing and publication post-publication and put \* mark in the work (as given in the draft). This responsibility includes answering any future queries about Methodology and Materials. Ensure that the e-mail address is given and that contact details are kept up to date by the corresponding author.
