In addition to philosophy, the author was able to use the methods of the general humanities at the interdisciplinary level in his work. It was concluded that each principle was "proven". 7.2 The operating principles are trivial, that is, not superficial. This item is rated "no". It was observed that the author presented each result after examining it from a theoretical point of view. At the same time, he is looking for ways to apply it to social and cultural practices. 7.3 The total number of scientific results and provisions is equal to five. The first provision is proven; a comparative analysis of the works of Plato, Aristotle, and other philosophers revealed the paradigmatic essence of Farabi's theory and methodology, presented in the "Classification of Sciences", which he later used to create the theory of music; The second position - the nature and essence of aesthetic perception and the role of the idea of experiencing music with the body was first analyzed on the basis of a detailed analysis of the works of contemporary scientists; The third principle - reveals the exclusive role of

Al-Farabi as the founder of Islamic philosophy, which is to synthesize theory and practice in the substantiation of philosophy and music theory by comparing and analysing the works of Eastern philosophers, and interpreting the views of modern philosophers; The fourth provision - based on the analysis of the author's version of the translation of "Kitab al-Musika al-Kabir" shows the relationship and correlation of the methodology of music theory with the philosophy and logic of Al-Farabi; The fifth position - a detailed analysis of the works of Al-Farabi and their projection into modern studies of cognitive psychology demonstrates the logical structure of epistemological, aesthetic, and ontological components of the unity of philosophy and music through the justification of the concepts of "emotion" and "musical thinking". For the above reasons, this dissertation is rated "Yes". 7.4 The application of the provisions in the development of modern education and science, in the social environment is assessed as "broad". The main scientific results of the thesis can be fully used in the field of social sciences and humanities. musicology, cognitive psychology. The dissertation is rated as "extensive". We believe that based on

			this material it is possible to prepare a special scientific seminar or an online course in higher school, which are feasible in the future. 7.5 The main provisions of the thesis are sufficiently substantiated at the level of domestic and some foreign publications, approbated as required.
