### 1. General characteristics of the educational program

## 1.1 Purpose and mission of the EP

The purpose of the program is to prepare a highly qualified specialist with in-depth knowledge of customs, who professionally speak foreign languages; a specialist who knows how to analyze and manage the movement of goods across the customs border, capable of performing the functions of the head of the structural unit of customs authorities, a specialist in the field of customs, who is able to organize and conduct scientific research in the field of customs.

The mission of the EP is the formation of personnel potential – highly qualified specialists competitive in the domestic and international labor market in accordance with their needs and development prospects of the country and the region.

#### 1.2 Main indicators of EP

The standard term for mastering an educational program of the magistracy in the specialty "7M042\_\_ - Customs affairs" is 2 years (for full-time education). The complexity of the educational program of the magistracy in the specialty "7M042\_\_ - Customs affairs" is 120 credits. The volume of the master's program in full-time education, implemented in one semester, is 27-33 credits. The program is built on a budget and contractual basis, is practice-oriented in nature, taught in Kazakh, Russian and English. Awarded qualification: Master of legal sciences of the educational program "7M042\_\_ - Customs affairs".

## 1.3 Brief description of the EP.

The educational program in the specialty "7M042\_\_ - Customs affairs" regulates the objectives, expected results, content, conditions and technologies for the implementation of the educational process, assessment of the quality of student training. EP is carried out on the basis of the curriculum, which is formed on the basis of the modular principle, on the basis of the competence approach. The plan displays a logical sequence of learning cycles and disciplines, as well as practices that ensure the formation of relevant competencies. The modules are grouped into blocks of basic and major disciplines, including mandatory (college) and elective components. The component of choice is formed on the basis of professional standards of the World Customs Organization. The Master's educational program is designed to train qualified workers who can perform professional functions as the head of a structural unit of customs authorities, a specialist in customs declaration, customs logistics at enterprises and organizations (firms, companies, institutions) engaged in foreign economic activity, as well as a research fellow .

EP is aimed at the formation of graduates of general cultural and professional competencies necessary for successful activity and prepared for independent research, organizational and management activities.

#### 2. Qualification requirements in the format of learning outcomes

Upon completion of this program, it is expected that undergraduates will be able to:

#### 5. Description of the benefits and features of the EP in terms of positioning in the educational market

The educational program in the specialty "Customs" complies with international professional standards adopted by the WCO and the EU.

According to the results of the rating of the IAAR and IQAAA, the "Customs" educational program ranks first in Kazakhstan in 2017 and in 2018.

To implement the educational program at the faculty there are the following laboratories and research centers:

- 1 Center for the fight against crime;
- 2 Research Center "Legal support of innovative development of Kazakhstan";
- 3 Center for Environmental Safety and Environmental Law;
- 4 Scientific Consulting Legal Center "Nurly Zhol Silk Road". Base practices:
- the system of central and local executive authorities at all levels,
- the system of central and local legislative bodies of all levels,
- national security agencies
- international organizations,
- non-governmental organizations and enterprises.

Staff potential. The faculty in the amount of 90 people focused on four departments. The faculty includes well-known scientists: 29 doctors of legal sciences, 50 candidates of legal sciences and 15 doctors of PhD. Among them, 16 winners of the grant "The best teacher of the university", 10 winners of the state scientific scholarship for talented young scientists, 8 winners of state awards. Teaching is also carried out by foreign professors and practitioners. Representatives of employers take an active part in the preparation of doctoral candidates: Parliament, Government, Ministry of Finance of the Republic of Kazakhstan, customs authorities.

The learning process is carried out in three languages, using the latest educational technologies. The best modern educational methods are used, among which are game trials, business games, trainings, as well as a combination of individual and team work.

Academic mobility. Every year, students studying doctoral studies in the specialty "Customs" have the opportunity to go on scientific internships at leading universities of the world for three months. There are agreements on mutual cooperation in the preparation of doctoral students with universities of the Russian Federation, China, South Korea, USA, France, Germany, Great Britain, Poland, Finland, Latvia, and Lithuania. Scientific advisors of doctoral students are leading scientists of the Republic of Kazakhstan and foreign countries.

Doctoral students are actively involved in the implementation of research, funded by the Ministry of Education and Science of the Republic of Kazakhstan, funded from other sources, in the organization of scientific conferences and theoretical seminars, the preparation and publication of monographs, scientific articles and reports. During the preparation of dissertation research doctoral students go abroad to work in scientific libraries of leading foreign research centers and universities.

Comparison with similar programs of foreign universities. The educational program in the specialty "Customs affairs" complies with international standards. Focuses on similar programs of foreign universities in England, USA, Europe and Asia.

## **6. Requirements for applicants**

Professional education - master's degree is carried out on the basis of higher education. Admission to the magistracy is carried out on a competitive basis on the basis of the entrance exams in accordance with the "Model rules for admission to universities".
