**DETAILS OF THE AGREEMENT FOR STUDENT EXCHANGE
BETWEEN
AI-FARABI KAZAKH NATIONAL UNIVERSITY, REPUBLIC OF KAZAKHSTAN
AND
THE UNIVERSITY OF TSUKUBA, JAPAN**

Al-Farabi Kazakh National University (President: Galimkair Mutanovich MUSTANOV), Republic of Kazakhstan and the University of Tsukuba (President: Nobuhiro YAMADA), Japan, hereby agree to establish a student exchange program as stated in Part (2), Article 2 of the Agreement for Academic Exchanges and Cooperation between the two universities.

The following paragraphs establish the guidelines whereby this exchange program shall be implemented within the framework of the Agreement for Academic Exchanges and Cooperation between the two universities:

1. Student Exchange intended in the details of the Agreement is the student exchange regularly conducted by the two universities.
2. In the details of the Agreement, "exchange students" refer to the students participating in the exchange program determined. "The home university" refers to the university where the exchange students aim to graduate. "The host university" refers to the university which agrees to accept the exchange students from the home university.
3. Exchange students are finally chosen by the host university based on recommendation of the home university.
4. Exchange students shall continue as candidates for the degree at the home university and shall not be candidates for the degree at the host university.
5. The expenses required for dispatch of exchange students will be borne by exchange students except as stated in Article 6. Scholarships or similar grants provided by the home university or other organizations shall be used.
6. Exchange students shall be exempted from the testing fee, entrance fee and tuition fee (hereinafter referred as the "tuition fees") of the host university.
7. The number of exchange students exempted from the tuition fees shall be up to ten (10) students per year from each university. The goal is to maintain an approximate balance in the number of exchange students between the two universities in the period of this Agreement.
8. The period of exchange for individual students participating in this exchange program shall not exceed one year (twelve months).
9. Exchange students must have obtained language abilities required for study at the host university and must have studied at least one year (twelve months) at the home university before participating in the exchange program. Exchange students must return to the home university upon finishing studies at the host university.
10. The home university may duly recognize the credits earned by exchange students at the host university in accordance with its own regulations.
11. The two universities shall assist the exchange students to the fullest extent possible in studying and finding reasonable accommodation.
12. Student Exchange in accordance with the details of the Agreement shall start in the academic year of 2012.
13. The details of the Agreement may be amended by mutual agreement.

14. Either of the two parties may terminate the details of the Agreement. In such a case a prior notice of six (6) months in writing is required before the termination becomes effective.
15. The details of the Agreement are made in English in two copies, one for each university. Both versions are deemed authentic. The two parties shall keep one set of them equivalently and respectively.


