

## THE AGREEMENT

### between the Al-Farabi Kazakh National University (the Republic of Kazakhstan) and the Kangnam University (the Republic of Korea)

The Al-Farabi Kazakh National University represented by its Rector, Professor Tolegen A. Kozhamkulov and the Kangnam University represented by its President, Professor Shinil Yoon according to the Agreement between the Government of the Republic of Kazakhstan and the Government of the Republic of Korea on cultural cooperation from May 16, 1995, and also the Program between the Ministry of Education and Science of the Republic of Kazakhstan and the Ministry of Education and Human Resources Development of the Republic of Korea about cooperation in the field of education, assuming that the creative cooperation of higher institutions of the two states will promote further cooperation and mutual understanding between the peoples of the Republic of Korea and the Republic of Kazakhstan and increasing intellectual and innovation resources of two higher institutions, have agreed to make and sign the following Agreement on cooperation:

#### Article 1

Within the framework of existing opportunities the contracting parties will develop cultural, educational and scientific cooperation in various spheres of their life and activity on the basis of equality and mutual benefit.

#### Article 2

The contracting parties will promote introduction and improvement of quality management system for educational services of higher institutions and international accreditation of the separate programs and directions on training of cadres through the baccalaureate, magistracy and doctor degree programs.

#### Article 3

The contracting parties will promote an exchange of professors for educational and scientific research programs.

#### Article 4

The contracting parties will organize development of the joint international projects and conducting researches on mutually agreed topics.

#### Article 5

On the mutually beneficial agreement the contracting parties will organize an exchange of students, undergraduate students, post-graduate students, persons working for doctor degree programs and scientists with providing conditions, necessary for their work.

Article 6

The contracting parties will promote organizing of conferences, seminars, symposiums, round tables and discussions with publication of the reports, theses and scientific articles of professor and teaching staff of the universities.

Article 7

By commission of one part the contracting parties will establish scientific contacts and conditions with other educational institutions, enterprises and research institutes of Korea and Kazakhstan, and also with the representatives of foreign countries.

Article 8

The contracting parties will promote developing cooperation in the field of foreign economic relations by way of a regular exchange of official delegations and specialists in different spheres of science and culture, creative groups, organization of exhibitions, scientific and technical trades, etc.

Article 9

This Agreement will remain in force without any time limit.  
Each of the contracting Parties has the right to break the present Agreement notifying the other part in written form no later than three months in advance.

Article 10




