Admission rules

The Model rules for enrollment in educational institutions realizing professional educational programs of higher education

1. General provisions

1. Educational institutions of the Republic of Kazakhstan realizing professional educational programs of higher educations (further on – higher educational institutions) are open for enrollment for Kazakhstani citizens, foreign citizens and stateless persons having secondary general (general secondary), primary professional (technical and professional), secondary professional (post-secondary) and higher education.
2. The forming of student contingent of higher educational institutions is performed by the means of budget financing, placing of a state educational decree for the preparing of specialists (educational grants) and tuition at the own expense of citizens and other resources.
Equally with the citizens of the Republic of Kazakhstan the educational grant can be issued to persons with Kazakh nationality who own the citizenship of other states, foreign citizens and stateless persons who permanently reside in the Republic of Kazakhstan and to citizens of the Russian Federation, the Republic of Belarus, the Republic of Tadjikistan and the Republic of Kyrgyzstan
Other foreign citizens and stateless persons are accepted to higher educational institutions in accordance with the legislation of the Republic of Kazakhstan as well as with international agreements ratified by the Republic of Kazakhstan.
3. Admissions to higher educational institutions is carried out on the basis of applications of citizens on a competitive basis in accordance with the scores shown on the certificate, issued according to the results of the Common National Testing (further on – CNT) or the complex testing based on technologies developed by the National Testing Center of the Ministry of Education and Science of the Republics of Kazakhstan (further on – NTC).
4. The CNT is held for school-leavers of general secondary education of the current year. The complex testing is held for school-leavers of secondary general education organizations of recent years, graduates of primary and secondary professional

educational institutions (technical and professional, post-secondary), school-leavers of secondary schools studying abroad on the basis of exchange programs and not having taken part in the CNT, school-leavers of secondary schools with Uzbek, Uighur and Tadjik primary languages, school-leavers of republican music boarding schools and for citizens with foreign secondary education.

5. Admission of citizens for education on a fee basis is carried out by higher educational institutes.
6. Admission of citizens to higher educational institutions within the jurisdiction of the Committee of National Security of the Republic of Kazakhstan, Ministry of Defense of the Republic of Kazakhstan, Ministry of Internal Affairs of the Republic of Kazakhstan, Agency of the Republic of Kazakhstan on combating economic and corruption crime, Ministry of Emergency Situations of the Republic of Kazakhstan is carried out in accordance with the scores shown on the CNT certificate or complex testing according to Appendix 1.
7. Admission to higher educational institutions of citizens having a technical and professional, post-secondary education to related specialties within a shorter period of time on a fee basis is carried out by admission commissions of higher educational institutions except for medical specialties.
Admission to related specialties is carried out in accordance with the approved list.
Admission to higher educational institutions of citizens having a higher professional (higher) education to education within a shorter period of time on a fee basis is carried out by the selection committees of higher educational institutions.
8. Admission of foreign citizens on provided quota based on the state educational order to international higher educational institutions established by interstate agreements of two or more countries is independently carried out by the higher educational institutions.
Admission of foreign citizens to foreign language education on a fee basis is carried out according to the results of the complex testing, performed by higher educational institutions in the language of education.
9. For admission to educational institution an admission quota is established and approved by resolution #296 of the Government of the Republic of Kazakhstan dated 28 March 2008 "On the establishment of the admission quota for admission to educational organizations realizing professional educational programs of technical and professional, post-secondary and higher education".
The list of bachelor specialties and higher special education specialties, on which a quota of admission to higher educational institutions of the Republic of Kazakhstan has been set for citizens having graduated from agricultural schools is established according to Appendix 2 to these Model rules of admission.
10. Admission of citizens in the light of the state educational order regarding certain specialties of higher education which require work with state secrets is carried out in educational organizations having the permission of national security bodies.
11. Admission of citizens to specialties requiring special or art preparation (further on – art specialties) is carried out in the light of special or art examinations (further on – art examinations).
12. Admission of application for participation in the complex testing is carried out by selection commissions of higher educational institutions from 20 June until 9 July.
Admission of applications to art specialties is carried out by selection commissions of higher educational institutions from 20 June until 1 July.
Citizens applying for art specialties select only one art specialty,
Periods of application submission to higher educational institutions within the jurisdiction of state as shown in paragraph 6 are established by corresponding state bodies.

13. Citizens applying for art specialties pass art examinations held by selection commissions of higher educational institutions of their choice. The quantity of art examinations is two. The art examination takes place from 2 to 7 July.
The maximal score of the art examination is 25. Prospective students who got the score of 10 or less at the art examination or who were absent will be debarred from the complex testing for admission to the selected specialty.
Retake of the art examination is not allowed.
14. Applications for admission to art specialties and to higher educational institutions within the jurisdiction of state bodies as shown in paragraph 6 except for higher educational institutions within the jurisdiction of the Committee of National Security of the Republic of Kazakhstan will be accepted at the location of the University.

2. Conduction of the complex testing

15. The complex testing is held on the basis of complex testing locations (base universities), the list of which will be approved by the decree of authorized body in the area of education.
The complex testing of citizens applying for art specialties and applying for higher educational institutions within the jurisdiction of bodies as shown in paragraph 6 will be held at the base university to which the university selected by the citizen is attached.
16. For the conduction on of informational explanatory works on locations state commissions on the organization and conduction of complex testing of prospective students are established (further on – state commissions).
The state commission is responsible for taking the decision about the cancellation of the results of testing of prospective students who use prohibited items during the test (informational materials, e-books, calculators, mobile phones, pagers and other means of communication) with protocol registration.
17. For participation in the complex testing the citizen must provide an application in accordance with the prescribed form, certificate or diploma of primary professional (technical and professional) or secondary professional (post-secondary) educational institution (original), receipt of payment for the testing, two 3x4 photos, 086-U medical reference and a photocopy of the identity document.
18. The complex testing is held from 17 to 23 July.
19. The citizen who has come to the complex testing must show his/her identity document and examination pass.
20. The complex testing is held in Kazakh or Russian language according to the wish of citizens within the frameworks of study programs of secondary education on four subjects: Kazakh or Russian language (language of education), history of Kazakhstan, mathematics and an elective subject, which is defined depending on the selected specialty according to Appendix 3.
21. The quantity of test questions on each subject is 25. A correct answer to each test question is equal to one point.
For citizens applying for art specialties points for two subjects of the complex testing are counted: for Kazakh or Russian language, history.
22. The time prescribed for the complex testing is 2 hours 30 minutes. Retake of the test is not allowed.
23. The processing of the results of the complex testing is performed at the university where the complex testing was held.
24. Keys to the correct answers are hung out directly after the completion of the scanning process of answer sheets, performed after the testing.
25. The results of the complex testing are announced on the day of its conduction.

26. According to the results of the testing each participant gets a standard certificate which is issued by the state commissions within three days after the testing.
27. A citizen who does not agree with the results of the testing may apply for appellation. The appellation commission is established in each base university. Controversial questions about the content of testing questions are considered by the republican appellation commission.

3. Enrollment to universities

Enrollment to the list of students is performed by selection committees of higher educational institutions from 10 to 25 august.
